

MINI SKID STEER BOXER-320 RENTAL AGREEMENT

RATES

Mini skid steer has a daily rate of \$200 per day. \$600 per week. Delivery each way \$40 to Vancouver area.

SECURITY DEPOSIT

Security Deposit in the amount of \$500 is required at time of rental. To <u>reserve</u> a unit, you must leave an additional \$50.00 deposit. The \$50.00 deposit is <u>NON-REFUNDABLE</u>, but will be credited towards your rental. (Customer must sign a credit card authorization form). You may use cash or charge this amount on a credit card (VISA, MasterCard, American Express or Discover). Security deposit will also be utilized to cover daily rental charges, dump fees, cleaning charges, or any other charges. <u>We will credit your card when unit is returned and checked in with no damage.</u> <u>Any damages will be deducted from your security deposit. Any damage amounts over the security deposit amount will be added to your credit card charge.</u>

CLEANING/OTHER CHARGES

Units must be returned empty and clean inside and out. If they are not cleaned, Renter will be charged a minimum fee of \$25.00. *This will be deducted from the aforementioned security deposit (please see above paragraph for reference)*. Equipment must be returned in the same condition as it was when picked up. Clean and damage free no exceptions! Renter shall pay all charges incurred in connection with the rental. Renter agrees that if the person or company indicated by renter to be responsible for payment fails to make payment, renter on demand agrees to pay all charges. The renter is responsible for any charges while in possession of the equipment. There are no refunds for early returns.

DROP OFF AND PICK UP OPTION

Equipment can be dropped off at your location and picked up when you are ready. Each trip is \$40 each way.

INSURANCE & DRIVERS LICENSE

RENTER MUST PROVIDE A <u>CURRENT</u> INSURANCE CARD FOR THE VEHICLE PULLING THE TRAILER. Towing vehicle registration and insurance card must be in the name of the person signing the rental agreement. CUSTOMER MUST SUPPLY A <u>CURRENT</u> DRIVERS LICENSE. Customer must be 18 years or older.

TOWING VEHICLE

All tow vehicles must be of proper size and MUST HAVE the proper hitch, and proper towing equipment. Hitching and wiring MUST be in good working order. Tow vehicles are not covered by Underline HDD insurance. If trailer is damaged by a tow vehicle, renter shall pay for all damage, loss of use and towing as mentioned in the LOSS OR DAMAGE section. Any additional licenses or permits required by provincial authorities are the responsibility of the renter.

TOWING ACCESSORIES

Tow hitch, adapter plug, tie-down straps, hitch pins and other items that may be needed for your trailer are available for rent. Dump trailer requires 7 way RV wiring plug and a ball tow hitch.

ACCIDENTS

First call the Police (911), then notify your insurance provider and lastly notify UnderlineHDD at 360-619-2479. Renter shall report any accident or theft involving the trailer to the police and shall complete a written report as soon as possible; in any event within 24 hours. Renter shall also report to their insurance.

THEFT

If trailer or equipment is stolen, notify the Police (911), then call Underline HDD at 360-619-2479.

LOSS OR DAMAGE

Renter shall pay Underline HDD LLC for all loss, damage and/or mechanical repairs to trailer, equipment, tools, and/or accessories, regardless of fault, resulting from abuse and/or misuse and/or negligence. Renter agrees to pay a sum equal to the regular daily rental rate each day the equipment is unavailable for rent, regardless of fault, while any damage and/or mechanical repairs are made. Repairs must not be performed by renter unless authorized by Underline HDD. Underline HDD is not responsible for loss or damage of any property left in, upon or carried in the trailer. Renter agrees to pay for any and all damage and/or mechanical repairs resulting from the trailer being overloaded or improperly loaded or resulting from an insecure load.

PROHIBITED USE

The equipment of this contract shall not be used by anyone not specifically named in this agreement.

The equipment of this contract shall not be used by anyone whose ability to operate the tow vehicle is impaired by alcohol, drugs or fatigue.

The equipment of this contract shall not be used outside of a 25 mile radius from Vancouver, WA without written consent.

The equipment of this contract shall not be used in any contest.

The equipment of this contract shall not be used in violation of any law.

REPOSSESSION

Underline HDD may terminate this agreement and repossess the equipment at any time or place.

DELAYS AND BREAKDOWNS

Underline HDD is not responsible for loss of time, wages, inconvenience, loss of use of the vehicle or other consequential damage or experience. Underline HDD is not responsible for any costs associated with changing the tire in case of a roadside flat. We may be available to assist if needed. Please call Underline HDD and inquire on availability if customer is in need of assistance due to breakdown.

WAIVER AND RELEASE

I, hereby (A) waive, release, and discharge from any and all liability for the death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my family and friends (B) hold harmless Underline HDD for any and all liabilities and claims made by other individuals or entities as a result of any of my actions or the actions of any associates, employees or reps.

I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTAND THIS RENTAL AGREEMENT AND THE WAIVER AND RELEASE DESCRIBED HEREIN.
